Release and Waiver of Liability

These Risks include, but are not limited to, exposure to and/or infection with contagious viruses and/or bacteria even in ideal conditions, and despite any and all reasonable efforts made to mitigate such Risks. I further agree to follow all safety precautions outlined by any Released Party while participating.

In consideration of and in order to be allowed to participate in the Activities, I do hereby release and forever discharge and hold harmless the Released Parties and their successors and assigns from any and all liability, claims, demands, costs and damages of any kind, whether arising from tort, contract or otherwise, which I or my heirs, assigns, next of kin or legal representatives may have or which may hereinafter accrue, arise from, or are in any way related to my Activities with any of the Released Parties, including but not limited to Risks, whether caused wholly or in part by the simple negligence, fault or other misconduct of any of the Released Parties or of other participants or volunteers, other than their intentional or grossly negligent conduct.

I understand and acknowledge that by signing this Release I knowingly assume the Risks associated with the Activities. I also understand that the Released Parties do not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury, illness, death or property damage.

Further, a waiver of a right under this Release by a Released Party does not prevent the exercise of any other right.
